## Health and Safety Representative Refresher Occupational Health and Safety Training Course – 1Day Course

The *Occupational Health and Safety Act 2004* (s67) makes provision for Health and Safety Representatives to attend a one-day refresher course once in each year. This course is approved by WorkSafe Victoria as refresher training under the Act. It will provide participants with the opportunity to update their health and safety knowledge including any changes to the *Occupational Health and Safety Act 2004* and the *Occupational Health and Safety Regulations 2017*. Managers and supervisors would also benefit from attending to update their OHS knowledge.

**The topics covered include:**

Update on changes to the OHS legislation including new manslaughter provisions.	Update on key parties and their legislative obligations and duties
Review representation in the workplace	Participating in consultation & issue resolution
Representing designated work group members in any OHS risk management process undertaken by employers	Update on the powers of a HSR under the OHS Act

**Training entitlement:**

An employer must if requested by a HSR (or deputy HSR) allow the HSR to attend a WorkSafe approved initial course of training in OHS after being elected and a refresher course at least once each year. The course to be attended by the HSR must be chosen by the HSR in consultation with their employer.
