### Health and Safety Representative Initial OHS Training Course

***Are your health and safety representatives adequately trained (per s67, OHS Act) to effectively exercise their rights and powers? Do your managers and supervisors understand the obligations imposed by Victoria's Health and Safety Legislation?***

**Introduction:**

This 5-day, **HSR Initial OHS Training Course** is formally approved by WorkSafe Victoria for Health and Safety Representatives. Although HSRs are the primary audience for this course, other persons such as Managers and Supervisors will benefit from attending. Five days of intensive training provides participants with a comprehensive knowledge of rights and powers of HSRs and practical skills to assist in the implementation of those rights and powers. The course is conducted by OHS professionals currently involved in assisting workplaces to effectively implement health and safety.

**The topics covered include:**

Interpreting the OHS legislative framework and its relation to the HSR	Identifying key parties and their legislative obligations and duties
Establishing representation in the workplace	Participating in consultation & issue resolution
Representing designated work group members in any OHS risk management process undertaken by employers	Exercising the powers of a HSR under the OHS Act

**Training entitlement:**

An employer must if requested by a HSR (or deputy HSR) allow the HSR to attend a WorkSafe approved initial course of training in OHS after being elected and a refresher course at least once each year. The course to be attended by the HSR must be chosen by the HSR in consultation with their employer.
